#### About the John Oxley Library Awards

The [Queensland Memory Awards](#) recognise contributions of individuals and organisations in the investigation, preservation, and celebration of Queensland's memory – past and present – through residencies, fellowships and awards.

The [John Oxley Library Award](#) and the [John Oxley Library Community History Award](#) are awarded annually to individuals and organisations that have contributed to advancing our understanding of Queensland's history and heritage.

Using this form you can nominate an individual for the John Oxley Library Award (recognition only) or an organisation or group for the John Oxley Library Community History Award (one-off gift of \$5,000).

While nominations are accepted at any time, the selection process occurs after the annual Queensland Memory Awards call for nominations closes. In 2024, this will be mid-August.

#### The John Oxley Library Award

The John Oxley Library Award recognises an individual who had made an outstanding contribution to the appreciation of Queensland history. The award is granted annually to promote the value of pursuing historical knowledge and its role in shaping Queenslanders understanding of themselves and each other.

The achievement being recognised may relate to any aspect of Queensland's social, political, economic and cultural life; and may take any form, occurring in any context, and extending over any period of time.

#### The John Oxley Library Community History Award

The John Oxley Library Community History Award is gifted annually for outstanding contributions by community organisations or groups in the preservation, recording and sharing of Queensland history. This Award celebrates the people involved in projects that help Queenslanders better connect with their stories, both past and present.

- The John Oxley Library Award is awarded to an individual.
- Interstate residents are eligible.
- Individuals cannot self-nominate for this category.
- Nominees do not need to be currently employed.
- A post humous nomination can be made in this category.
- The achievement being recognised can be a specific activity, or a combination of contributions/activities over time.
- University or Australian Research Council (ARC) research teams are ineligible.
- Current State Library of Queensland employees and board members are ineligible.

### **The John Oxley Library Community History Award**

- Open to Australian community organisations or groups.
- The John Oxley Library Community History Award is awarded to an organisation or group, not an individual who is part of an organisation or group.
- Interstate organisations or groups are eligible.
- Individuals cannot self-nominate for this category.
- University or Australian Research Council (ARC) research teams are ineligible.
- Current State Library of Queensland employees and board members are ineligible.

### **Who can submit a nomination?**

- External nominations for both awards are welcome via SmartyGrants.
- You can nominate an individual for the John Oxley Library Award or an organisation or group for the John Oxley Community History Award.

### **How are winners awarded?**

- An independent judging panel made up of professionals with expertise in the related field access all nominations. Longlist is developed by State Library.
- Judges assess the nominees against the selection criteria.
- Judges decide on a shortlist and a successful nominee for each category.
- Judges award the nominee with the highest merit against the selection criteria. Panels must decide on one successful nominee per each award per category each year.
- The judges may, at their discretion, consult with other experts to assist in evaluating the merits of each nomination.
- The outcomes of the judging process are final, and no discussion or correspondence will be entered into regarding decisions or the judging process.
- Judges may choose not to award a category if there are no nominations of suitable merit.
- The names of the judges will be published at the conclusion of the judging process.
- Judges must disclose any actual, potential, or perceived conflicts of interest as soon as they become aware of them. State Library of Queensland records all conflicts of interest, perceived, potential and actual. The conflict of interest is managed by the State Library.

The selection process occurs after the annual Queensland Memory Awards call for nominations closes. In 2024, this will be mid-August.
